

## Participant Disclaimer Uster Triathlon 2022

**All participants must sign this disclosure, and bring it with them on the day of the race, in order to register.**

- 1) As a participating athlete, I accept that I am obliged to observe the rules of the organizer, and in accordance with the Swiss Triathlon Regulations.
- 2) I confirm that I am physically fit to compete in this race, and that I have undergone sufficient training to participate in the race. I also certify that I have not been advised otherwise by a qualified medical professional.
- 3) I certify that I have sufficient insurance coverage in the event of illness or accident.
- 4) I confirm that I am aware there are dangers in participating in sporting events, and in the race I am registering for, and that the risk of serious injury or fatality cannot be fully excluded.
- 5) I acknowledge that I carry the sole responsibility for my own personal belongings, including sporting equipment. I accept that the organizers shall not be held liable for any loss or damage to personal belongings and sporting equipment.
- 6) I confirm and agree that my registration details may be made public through Result Service or similar third parties.
- 7) I understand that during the event there will be photographs, films and interviews taken during this event that I may feature in, and that I consent to any images or recordings being used, for any legitimate purpose, by the event holders, producers, sponsors, organizers, and assignees, without compensation. A legitimate purpose includes use for advertisement.
- 8) I agree that my email address will be stored and used to send regular newsletters with information and offers around triathlon. Your data will only be used for this purpose and will not be given to a third party. You can revoke your permission at any time using the link «Unsubscribe» at the end of the newsletter.
- 9) I accept that the liability of the organizers, managers and volunteers of the Uster Triathlon and GreifenseeSwim is limited to nil. I therefore release the aforesaid from all claims, as far as these claims are not covered by legal liability. Herein, all immediate and mediate damages are included, as well as all claims that I or my inheritor or other authorized third parties may assert in relation to any injury or fatality.
- 10) I have noted, that the entry fees are rising gradually. I know, that if the event cannot be held or can only be partially held because of natural causes, no refund will be given.
- 11) I have read and acknowledged the COVID-19 measures and policies in place and herewith commit to adhere to them. With my signature I confirm that I am healthy, showing no signs of illness and/ or COVID symptoms and that I have not been in contact with people who have tested positive for COVID-19 in the past 14 days.
- 12) I agree that in case of withdrawal from the registration (no start) the entry fee can only be refunded if the participant has chosen and paid the cancellation-option (CHF 10.--) at the inscription. It covers exclusively withdrawal for medical reasons.
- 13) If the participant wishes to avail from this „cancellation option“, he has to submit within 48h after the withdrawal and before the event a detailed medical certificate (incl. diagnosis) to event@mooveme.ch. Refunded will be the paid entry fee with a deduction of a CHF 10.-- handling fee. Any further services are out of question.
